RELATING TO MANDATORY QUARANTINE****Period of Quarantine Order, 2020**

THE Superintendent of Public Health notifies that in accordance with Article 2 (1) of the Period of Quarantine Order, 2020, the provisions of the said order are hereby being suspended with effect from the 28th May, 2020, relative to the persons on Flight No. 9H-ELI CITATION X travelling from Malta to Libya on the 28th May, 2020, and returning on Flight No. 9H-ELI CITATION X travelling from Libya to Malta on the 28th May, 2020, for quarantine period related to this flight.

This suspension is granted on the basis that the persons travelling on these flights provide an essential service, the very limited period of time that was spent abroad, national security emergency relating to the travel and urgency of the trip abroad.
