Id-Direttur Ġenerali tal-Uffiċċju għall-Kompetizzjoni jgħarraf għall-informazzjoni ta' kulhadd illi skont regolament 5(4) tar-Regolamenti tal-2002 dwar il-Kontroll ta' Konċentrazzjonijiet ippubblikati fl-Avviż Legali 294 tal-2002, li notifikazzjoni ta' konċentrazzjoni bejn Centerbridge Partners, L.P (New York, L-Istati Uniti) u Speedcast International Limited (New South Wales, L-Awstralja) giet ipprezentata nhar l-Erbgħa, 9 ta' Diċembru, 2020.

In terms of regulation 5(4) of the Control of Concentrations Regulations, 2002 published in Legal Notice 294 of 2002, the Director General of the Office for Competition notifies for general information that a notification of a concentration between Centerbridge Partners, L.P. (New York, United States) and Speedcast International Limited (New South Wales, Australia) was filed on Wednesday, 9th December, 2020.

Il-konċentrazzjoni hija akkwist ta' kontroll assolut ta' Speedcast International Limited minn ċerti entitajiet affiljati ma' Centerbridge Partners, L.P.

The nature of the concentration is an acquisition of sole control of Speedcast International Limited by affiliates of Centerbridge Partners, L.P.

Centerbridge Partners, L.P. hija kumpanija privata tal-immaniġġjar tal-investimenti, b'uffiċċini li jinsabu fl-Istati Uniti u f'Londra, li tħaddan metodi flessibbli ta' investment fuq numru ta' dixxiplini, li jvarjaw minn ekwità privata għal kreditu u strateġiji relatati, għal proprjetà immobbli. Speedcast International Limited hija kumpanija internazzjonali attiva fil-qasam ta' komunikazzjoni remota u tipprovdi servizzi relatati mal-informazzjoni teknoloġika. Din il-kumpanija topera f'erba' oqsma tan-negozju: tal-Marittimu u Cruise Kummerċjali, tal-Energija, tal-Intrapriża u Swieq Emerġenti u tal-Kummerċ tal-Gvern.

Centerbridge Partners, L.P. is a private investment management firm with offices in New York and London, which employs a flexible approach across investment disciplines, ranging from private equity to credit and related strategies to real estate. Speedcast International Limited is an international remote communications and information technology services provider, which operates across four business segments being Commercial Maritime and Cruise, Energy, Enterprise and Emerging Markets and the Government Business.
